







Reminders

- Please do not include stars3awardees@gsa.gov in the "to" or "cc/bcc" line when replying to emails that were sent to your STARS3 group email address. Including only the intended recipients ensures that your email is not mass distributed to all 8(a) STARS III industry partners.
- Add "ReportingInquiries@gsa.gov" to your approved sender list. A team of program analysts supporting the STARS III team will send notices when required reporting is delinquent from the "ReportingInquiries@gsa.gov" email address.
 Failure to report timely or respond to a request for action will impact your STARS III performance record!
- Pro Tip: Never be late on reporting again! Create a visual aid to remind you of reporting requirement due dates. Set a monthly calendar reminder to review and report any necessary actions!
