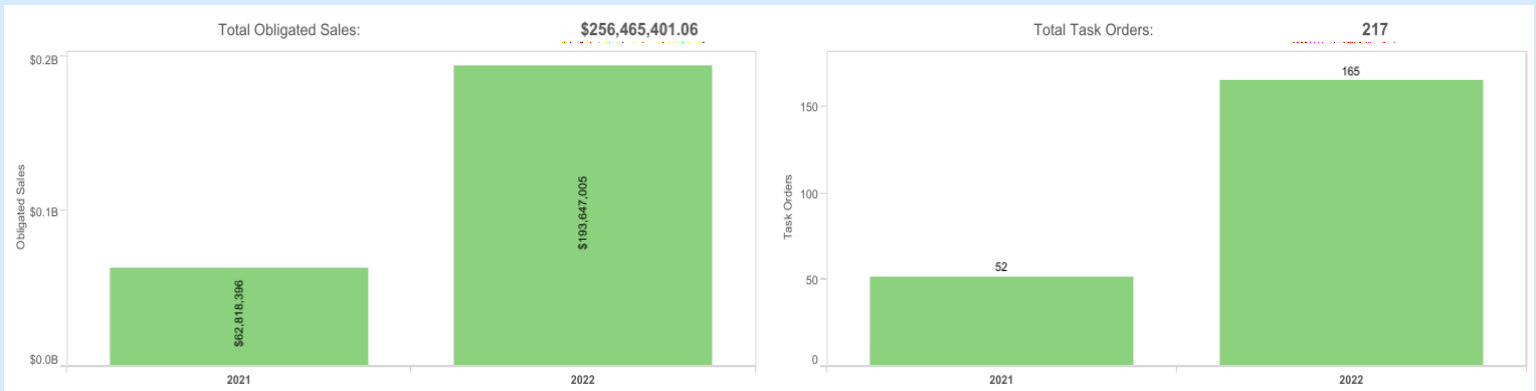

- This notice is for all Industry Partners who have received an email with the subject line: "Reminder to create a change of name, or novation modification." We've been made aware of a change where the SAM.gov's entity validation process is making certain minor punctuation (periods, commas, etc.) and abbreviation changes in a company name or address. This is resulting in a mismatch between an entity's name in SAM.gov and various GSA systems and is triggering a Name Change, Address Change, or Novation modification notification. We are actively pursuing a way to address this change in a consistent and legally sufficient way. In the meantime, please ignore these emails unless in fact you do require a Name Change, Address Change, or Novation modification. Thank you for your patience and understanding.
