

Significant Changes For the GSA Multiple Award Schedule (MAS) Solicitation (Interact post attachment)

DISCLAIMER: GSA FAS is posting this notification of a planned solicitation refresh or mass modification as a courtesy to industry. All comments on the attached DRAFT document must be submitted in the "Comments" section below within ten (10) business days of this posting. Comments provided elsewhere or after 10 business days will not be considered. GSA FAS will consider all relevant comments and make changes to the DRAFT as appropriate, but will not issue a formal response to industry comments or related inquiries. Interested parties should thoroughly review the final version of the solicitation refresh or mass modification for changes made to this DRAFT.

GSA anticipates that the refresh will occur in April 2024.

Summary of Planned Changes Below is a high-level description of significant changes to be included in the upcoming MAS refresh and mass modification. Be sure to review the final solicitation refresh and mass modification for full details.

A: Changes to Overall MAS Solicitation:

1. **Incorporate the following updates to SCP-FSS-001** (see GSA Interact notice attachment for revised text):
 - a. Revise **(d)(2)** to:
 - i. Sales under the existing contract comply with clause I-FSS-639, *Contract Sales Criteria* for the previous five years of reported sales.
 - b. Revise **(i)(1)(iv)** to:
 - i. Bring back **bullet (A)** A copy of the cancellation letter or notification of determination not to exercise an option
 - ii. Address 12-month waiting period if contract is canceled/allowed to expire due to **non-compliance**
 - iii. Revise **bullet (B)** defining current federal sales; awarded within 12 months of offer submission that individually or in the aggregate exceed \$25,000
 - iv. Revise **bullet (C)** to highlight non-compliance with clause I-FSS-639, Contract Sales Criteria

- v. Revise **bullet (D)** to clarify parameters (limit 2 pages, 1.15 space, times new roman, size 10 font, one inch margins) describing your marketing strategy
- c. Add below note to **(i)(1)(xviii) GSA Advantage Purchase Order (PO Portal)**
 - i. Note: Contractors must provide a valid status for each order line no later than the specified number of days established as the 'Normal Delivery Terms' of the contract.
- d. Remove page references regarding Relevant Project Experience under **(i)(2)(iv)(A) & (B)** as fields are completed in the eOffer system
- e. Update various gsa.gov links and page titles

2. Add the following note to clause I-FSS-600:

- a. Note:
 - All Commercial Off the Shelf (COTS) and commercial type products are prohibited from being duplicated and published to the text file posted on GSA eLibrary.
 - All Commercial Off the Shelf (COTS) and commercial type products should be published for sale on GSA Advantage **OR** to the text file posted on GSA Advantage.
- Also, adding this note to the ['Electronic Catalog' VSC page](#), under 'What do I need to include in my electronic catalog for GSA Advantage?'

3. Various changes to Price Proposal Templates:

- a. Offer Price Proposal Template for Products
 - i. Update 'Read Me First' tab to reflect Refresh 20
 - ii. Add two new tabs for Options and Accessories
 - iii. Add instructional language for Options and Accessories to the 'Read Me First' tab
 - iv. Add 'Base Product or Accessory' column to all tabs
 - v. Update Glossary
- b. Modification Price Proposal Template for Products
 - i. Update 'Read Me First' tab to reflect Refresh 20
 - ii. Add two new tabs for Options and Accessories
 - iii. Add instructional language for Options and Accessories to the 'Read Me First' tab
 - 1. Note for Options:
 - a. For option item price increases or price decreases, utilize the associated EPA tabs with base products information only.
 - 2. Note for Accessories:

- a. This tab should only be used when adding/changing/removing an accessory relationship with the base item.
 - iv. Add 'Base Product or Accessory' column to all tabs
 - v. Update Glossary
 - c. Offer and Modification Services and Training Price Proposal Templates
 - i. Add instructional language for Mark-ups to the 'Read Me First' tab
 - 1. Contractors who offer mark-ups should enter the discount (X%), as a negative discount, from commercial pricing (commercial market rates or Commercial Price List rate) offered to the Most Favored Customer and GSA for the direct labor or task element entry.
 - d. SINs 541930 Translation and Interpretation Services 611630 Linguistic Training and Education
 - i. Add instructional language for Mark-ups to the 'Read Me First' tab
 - 1. Contractors who offer mark-ups should enter the discount (X%), as a negative discount, from commercial pricing (commercial market rates or Commercial Price List rate) offered to the Most Favored Customer and GSA for the direct labor or task element entry.
4. Incorporate clause and provision updates, as necessary, through Federal Acquisition Circular (FAC) 2024-04 and GSAR Change 178
- 5. Letter of Supply**
- a. Remove the below category and offerings requirements for the Office Management Category:
 - i. A. Manufacturers listed on the [Business Solutions Association \(BSA\)](#) website are part of the Dealer Authorization Program.
 - ii. D. A roster of wholesale agents and dealers segregated by manufacturer can be found on the BSA website. *[Vendor]* may also inquire with the manufacturer for information regarding its authorization status.

- a. Facilities Services (B02): SIN 561730 - Grounds Maintenance
 - i. Revise SIN description to include snow removal

2. Furniture (C):

- a. Large Category Attachment Instructions
 - i. Add the following note to the General Requirements section:

- b. IT Solutions Subcategory (F05): SIN 518210FM - Financial Management Quality Service Management Office (FM QSMO) Core Financial Management (FM) Solutions and IT Professional Services
 - i. Update various use cases in the [SIN 518210FM Core FS OCD Execution Plan](#) to maintain alignment with current versions of FMCL 2024 release - Business Use Case and the FIBF.

4. Miscellaneous (G):

- a. Complementary SINs (G06): SIN OLM - Order-Level Materials (OLM)
 - i. Revise SIN instructions to 60 OLM-eligible subcategories and add 'Transportation of Things' subcategory

5. Professional Services (H):

- a. Environmental Services (H02): Subcategory Instructions
 - i. Add the following statement to address climate change:

The following services may be utilized by ordering agencies to fulfill a broad range of Environmental services to include planning for and response to environmental issues including climate change.

- b. Environmental Services (H02): SINs 541620 - Environmental Consulting Services, 562910REM - Environmental Remediation Services & 562910RMI - Environmental Remediation Services - Multiple Industries
 - i. Revise SIN description to include climate change

6. Transportation and Logistics Services (K):

- a. Transportation of Things Subcategory (K05): SINs 481211B - Air Charter Services - Brokers & 481211O - Air Charter Services - Owner Operated
 - i. Revise Statement of Work (SOW) to account for changes in safety requirements for U.S. Commercial Air Carriers (i.e, Safety Management

Systems (SMS), SMS Inspection Certifications, safety requirements for Rotorcraft, and inclusion of expansion into Order-Level Materials (OLMs) SIN.
