This temporary closure will allow GSA to further consider its needs and the acquisition strategy associated with the Core FS Subgroup of SIN 518210FM. During this time, offers or modification requests to add the Core FS Subgroup of SIN 518210FM will not be accepted.

In order to support the government transition to the FM QSMO Marketplace, offers or modification requests to add financial management products and services under any of the following three Subgroups of SIN 518210FM will continue to be accepted:

- 1. Additional Financial Management (FM) Solutions
- Financial Management (FM) Service/Solution Adoption and Transition Services
- Financial Management (FM) Technology Operations Support Services

In order to implement this temporary closure, the following note has been added to SIN 518210FM in the Information Technology Category Attachment to the MAS Solicitation:

The Core FS Subgroup of SIN 518210FM is temporarily closed to new offers while GSA and the FM QSMO further evaluate agency needs and the acquisition strategy associated with this Subgroup. GSA has suspended solicitation of the Core FS Subgroup, and new offers or modification requests to add the Core FS Subgroup of SIN 518210FM will not be accepted.

Due to a system issue, the solicitation-level SF30 highlighting the significant changes included in MAS Solicitation 47QSMD20R0001 - Refresh #13 was not posted on the System for Award Management (SAM). In an effort to communicate the changes associated with Refresh 13, GSA has provided the following summary:

The General Services Administration (GSA) Federal Acquisition Service (FAS) issued GSA Multiple Award Schedule (MAS) Solicitation 47QSMD20R0001 - Refresh #13 and an associated mass modification (mass mod) to all existing contracts on June 30, 2022.

Outlined below are the changes associated with Solicitation 47QSMD20R0001 -Refresh #13:

A: Changes to Overall MAS Solicitation:

- 1. The following note will be added to 52.223-3 HAZARDOUS MATERIAL IDENTIFICATION AND MATERIAL SAFETY DATA (FEB 2021) (ALTERNATE I JUL 1995):
 - a. NOTE: Safety Data Sheets, hazardous material labels and other relevant data should not be submitted to the MAS Contracting Officer. This information should be provided directly to the ordering activity in accordance with this clause.

- Effective June 30, 2022, Multiple Award Schedule (MAS) contractors will be allowed to take an exception to FAR Clause 52.223-99 (October 2021 Deviation), Ensuring Adequate COVID Safety Protocols for Federal Contractors.
- a. GSA is allowing contractors to take an exception to this clause while any relevant injunctions prohibiting enforcement or inclusion of the clause remain in effect. This will allow MAS contractors to incorporate other pending critical terms and conditions into their contracts.
- 3. Updates have been made to the clauses/provisions below to implement the changes included in FAC 2022-06 and GSAR Changes 150 through 153:

- B: Changes to Specific Large Category, Subcategory or SIN:
 - 1. Facilities (B)
 - a. Facilities Services Subcategory (B02)
 - GSA will retire SIN 561210FS Facilities Support Services effective on 6/30/2022.
 - 2. Information Technology (F):
 - a. IT Solutions Subcategory (F05)
 - i. GSA will retire SIN 541519CDM Continuous Diagnostics and Mitigation (CDM) Tools effective on 6/30/2022.
 - ii. GSA will establish special ordering procedures for buying commercial cloud computing services under SIN 518210C Cloud Computing and Cloud Related IT Professional Services on a consumption basis.
 - 1. This change will not replace or restrict existing practices for acquiring cloud computing services, and will introduce procedures that may be used when an ordering activity wishes to acquire cloud computing on a consumption basis.
 - 2. These procedures follow many commercial best practices by providing a method to pay for cloud services based on actual consumption without the need to obligate the entirety of available funds at the start of the contract.
 - 3. GSA will revise SIN 518210C instructions to allow a pricing increment length
