What's New

Executive Order 14042: Ensuring Adequate COVID Safety Protocols for Federal Contractors

GSA appreciates the hard work and dedication of our contractors, especially during such an extraordinary time. As we've said many times since the pandemic began, the health and safety of GSA employees, contractors, and their families are our top priorities. In order to ensure the health and safety of the federal workforce and contractor community, the President signed Executive Order 14042. Ensuring Adequate COVID Safety Protocols for Federal Contractors.

The requirements in this Executive Order (EO) have been implemented across all government contracts via a Federal Acquisition Regulation (FAR) deviation. The clause in the FAR deviation were incorporated into GSA contracts via a bilateral modification.

GSA issued the Schedule refresh and mass modification to incorporate this change on October 8, 2021 and contractors had until November 14, 2021 to accept.

Retiring the Vendor Education Center

After a year-long assessment, we've decided to retire the outdated Vendor Education Center (VEC) and update our training! VEC will be retired in December of this year - at that time, we'll move our training to the gsa.gov MAS Roadmap, making it accessible from the new Vendor Support Center. Catalog Management Updates

GSA Awards Contract for Common Catalog Platform (CCP)

GSA's Catalog Management Office (CMO) is thrilled to <u>announce</u> that an award was made to CGI Federal to develop the new Common Catalog Platform (CCP). The CCP will replace the antiquated desktop-based Schedule Input Program (SIP) with a modern, Application Programming Interface (API)-accessible, web-based application for managing catalog data. The CCP will interact with contracting systems to streamline the offer and modification process, and reduce the administrative burden associated with working in disjointed systems. The CCP will also introduce new functionalities that make it easier to manage catalogs, and ultimately improve the quality of data collected for GSA Advantage!

The CMO is grateful to all of the members of the MAS community who contributed to the CCP requirements through focus groups and surveys over the last year, and we will continue to engage users as we design and develop the platform. Our goal is to pilot the CCP by next fiscal year, and will share more details as available. For regular updates, join the <u>Catalog Management Interact Page</u>.

Catalog Data Quality

GSA recently began collecting Commercial off the Shelf (COTS) product specifications and supplier authorization information directly from manufacturers and wholesalers via the new Verified Products Portal (VPP). We're now supplementing <u>contractor catalogs on GSA Advantage!</u> with VPP descriptions and images, ensuring customers see consistent information for COTS items whenever available.

The VPP also enables GSA to enforce product prohibition rules and <u>automate the Letter of Supply (LoS)</u> requirement for participating manufacturers and their authorized resellers. This helps protect against supply chain risks and improve customers' ability to purchase with confidence, while reducing the administrative burden associated with managing individual LoS.

Long term, we intend to provide this content to contractors through the CCP to make it easier to report product specifications and improve the consistency of information for customers. Manufacturers and wholesalers who are looking to improve the representation of their items in the federal marketplace should visit gsa.gov/VPP to get started.

Updates to Current MAS Programs

MAS Consolidation Phase 3

Have more than one MAS contract under the same DUNS number or Unique Entity Identifier (UEI)? There may be actions your company needs to take during Phase 3 of MAS Consolidation to move all your offerings to one surviving MAS contract.

All consolidation actions should be made in coordination with your GSA Contracting Officer and in accordance with your agreed upon Phase 3 Consolidation Checklist and Plan.

The deadline to submit your consolidation plan has been extended to December 31, 2021.

These consolidation plans are the first step in determining your surviving contract and start the process of getting to one contract per UEI. **No Phase 3 modifications will be approved without a completed and approved plan.**

Phase 3 Recorded Training for Impacted Contractors - August 2020 <u>Industry</u>. This new resource takes you through all the critical consolidation steps.

Note: If your company only manages two contracts and you fall under one of the following scenarios, Phase 3 DOES NOT apply to you:

- One contract has a small business set-aside (SBSA) Special Item Numbers (SINs),
- One contract is a follow-on contract with the same SIN(s).

Please submit your <u>Phase 3 Consolidation Checklist and Plan</u> to your Contracting Officer(s) (CO) as soon as possible to get the process started.
